

## **MEMORANDUM OF UNDERSTANDING**

This MEMORANDUM OF UNDERSTANDING (MoU) has been executed on 20-05-2022 at Kurukshetra by and between:-

**SETH NAVRANG RAI LOHIA JAI RAM GIRLS COLLEGE**, Lohar Majra, Kurukshetra-Pehowa Road, Kurukshetra (Haryana), (herein referred as 'Party No-I' which expression unless repugnant to the context shall mean and include its successors and assigns) of one part;

**AND**

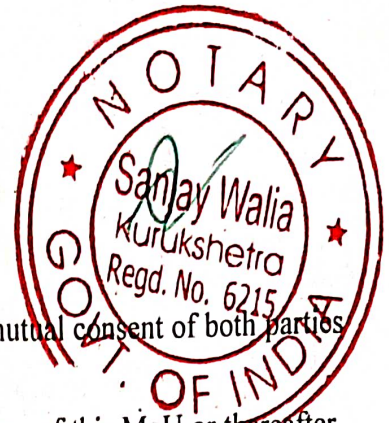
**Babu Ram Anant Ram Janta College, Kaul** (herein referred as 'Party No-II') of other part;

The Party No-I and Party No-II are hereinafter collectively referred to as "Parties" and severally each as 'Party'. This MoU/Agreement shall be effective from date of signing (20-05-2022).

### **IT IS NOW AGREED BY AND BETWEEN THE PARTIES HERETO AS UNDER:**

1. That both parties believe that close co-operation between the two would be a major benefit to the student community to enhance their skills and knowledge.
2. That both the parties will work to enhance and promote academic interest of students
3. That both the parties will work to promote quality of education in both the institutes.
4. That interaction between both parties will give an insight into the latest research/educational activities.
5. That both parties will share the logistic support (training halls/ rooms, video conferencing & recording, training aid, transportation etc) as and when required for conducting capacity building programmes successfully i.e. training, workshops, seminars, symposiums, camps, exposure visits and expert lectures on information technologies.
6. That both the parties will conduct Joint research projects and publications, including work by undergraduate, graduate students at the partner institutions;
7. That both the parties will initiate Faculty and student exchanges programmes.
8. That the record of all the activities should be maintained systematically by both the parties.
9. That the MoU is signed initially for a period of three years with effective from date of signing of MoU i.e. 20-05-2022. The stipulated period of MoU may further extend up to three years; however, this extension shall be purely on the basis of mutual consent of both parties.
10. That Part-I will work with Party-II on no profit no loss basis.
11. That the both parties may terminate MoU with prior notice of three months in writing which will be served at the registered address of opposite party.

12. That terms of this MoU may be amended as per time/ local needs with mutual consent of both parties in written.
13. That if any dispute arises between the Parties hereto during the subsistence of this MoU or thereafter, in connection with matters concerning therewith. The same shall be resolved through mutual consultation in amicable way only.
