



MEMORANDUM OF UNDERSTANDING

This MEMORANDUM OF UNDERSTANDING (MoU) has been executed on 02nd May, 2022 at Kurukshetra by and between:-

SETH NAVRANG RAI LOHIA JAI RAM GIRLS COLLEGE, Lohar Majra, Kurukshetra-Pehowa Road, Kurukshetra (Haryana), (herein referred as 'Party No-I' which expression unless repugnant to the context shall mean and include its successors and assigns) of one part;

AND

CHETANYA CAREER CONSULTANTS PVT. LTD., 3C Tower, Opp Gas Agency, Indri Chowk, Indri Road, Ladwa, Haryana-136132 (herein referred as 'Party No-II') of other part;

The Party No-I and Party No-II are hereinafter collectively referred to as "Parties" and severally each as 'Party'. This MoU/Agreement shall be effective from date of signing (02-05-2022).

IT IS NOW AGREED BY AND BETWEEN THE PARTIES HERETO AS UNDER:

1. That both parties believe that close co-operation between the two would be a major benefit to the student community to enhance their skills and knowledge.
2. That interaction between both parties will give an insight into the latest developments /requirements of the Job industries.
3. That both parties will share the logistic support (training halls/ rooms, video conferencing & recording, training aid, transportation etc) as and when required for conducting capacity building programmes successfully i.e. training, workshops, seminars, symposiums, camps, exposure visits and expert lectures on information technologies.
4. The Second Party will give valuable inputs and train students of the First Party on linguistic skills so that the students fit into the industrial scenario meaningfully and are able to bridge the gap in skill and are ready for industry.
5. The Second Party will extend the necessary support to deliver guest lecturers to the students of the First Party on the technology trends and in house requirements.

6. The Second Party will actively engage to help the delivery of the communication training to help students of the First Party get internships/jobs.
7. That the record of all trainings/IEC activities and related works should be maintained systematically by the first party.
8. That the MoU is signed initially for a period of one year with effective from date of signing of MoU i.e. 02-05-2022. The stipulated period of MoU may further extend up to three years; however, this extension shall be purely on the basis of mutual consent of both parties.
9. That Party -I will work with Party-II on no profit no loss basis.
10. That the both parties may terminate MoU with prior notice of three months in writing which will be served at the registered address of opposite party.
11. That terms of this MoU may be amended as per time/ local needs with mutual consent of both parties in written.
12. That if any dispute arises between the Parties hereto during the subsistence of this MoU or thereafter, in connection with matters concerning therewith. The same shall be resolved through mutual consultation in amicable way only.
