



MOUMEMORANDUM OF UNDERSTANDING

This Memorandum of Association has been made and executed at Kurukshetra on this the 7th day of January, 2022.

BETWEEN

SETH NAVRANG RAI LOHIA JAI RAM GIRLS COLLEGE, Lohar Majra, Kurukshetra - Pehowa Road, Kurukshetra (Haryana). (herein referred as '**Party No-I**' which expression unless repugnant to the context shall mean and include its successors and assigns) of one part;

AND

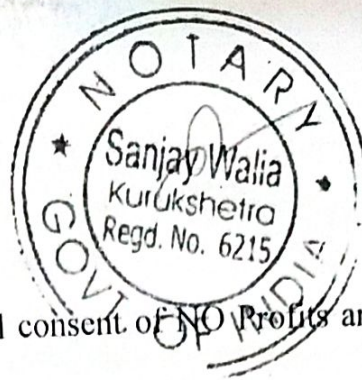
RATH Foundation, a registered NGO working for Youth and Women empowerment, Education and Environment having its registered office at 142 Sector 6, HUDA, Panipat through Mr. Arjun Kadian on behalf of Chairperson Smt. Shakuntla Devi (herein referred as '**Party No- II**') of other part;

The Party No I and Party No II are hereinafter collectively referred to as "Parties" and severally each as "Party". This MoU/ Agreement shall be effective from date of signing (07-01-2022).

IT IS NOW AGREED BY AND BETWEEN THE PARTIES HERETO AS UNDER:

1. That the both parties will work together for attaining and sustaining goal of Environment Protection, Social Welfare and Social Development.
2. That both parties will share the logistic support as and when required for conducting training, camps, expert lectures and activities for awareness.
3. That the record of all social welfare activities and related works should be maintained systematically.
4. That the MOU is signed initially for a period of three years with effective from date of signing of MOU. The stipulated period of MOU may further extent up to three years; however, this extension shall be purely on the basis of mutual consent of both parties.

5. That Party-I will work with Party-II at mutual consent of NO Profits and NO Loss basis.
6. That the parties may terminate MOU with prior notice of three months in writing which will be served at the registered address of opposite party.
7. Those terms of MOU may be amended as per time/ local needs with mutual consent of both parties in written.
8. That if any dispute arises between the parties hereto during the subsistence of this MOU or thereafter, in connection with matters concerning therewith. The same shall be resolved through mutual consultation in amicable way only.
